The house is hot air propane fired heat that the tenant pays direct to vendor. Water and sewer charges are paid by the tenant. Snow and grounds are paid by the landlord.

As you complete the application process, please note the following:

- 1. Your household income must total at least \$30,000 annually. We will ask for verification of all sources of income.
- 2. We will contact you and schedule a time to show you the house. After you see the house if you decide to proceed with your application, we will collect a \$30.00 fee for a credit history and criminal background report for each applicant and each household member over the age of 18.
- 3. After reviewing the application (including the credit history and criminal background report(s), we will contact you to tell you whether your application has been approved, and if so, we will offer you the house.
- 4. If you accept the house, we will ask you to provide us a \$400.00 non-refundable deposit, which will be applied toward your security deposit. We will also schedule a time to meet you to sign the lease. You will be required to pay the balance of your security deposit and the first month's rent at the time the lease is signed.
- 5. Pets may be allowed with discretion.
- 6. Tenant pays for the propane usage for heat and reimburses landlord for the sewer and water charges.
