All of the apartments are “townhouse” style with the kitchen, living/dining areas and a ½ bathroom on the first floor and two bedrooms and 1 full bathroom on the second floor. All apartments also have exclusive basement storage space which can be accessed from inside the apartment. Coin-operated laundry facilities are available in the common areas of the basement. The heat is included with the rent.

As you complete the application process, please note the following:

1. Your household income must total at least \$41,000 annually. We will ask for verification of all sources of income.
2. When an apartment becomes available, we will contact you and schedule a time to show it to you. After you see the apartment, if you decide to proceed with your application, we will collect a \$30.00 fee for a credit history and criminal background report for each applicant and each household member over the age of 18.
3. After reviewing your application (including the credit history and criminal background report), we will contact you to tell you whether your application has been approved, and if so, we will offer you the apartment.
4. If you accept the apartment, we will ask you to provide us a \$400.00 non-refundable deposit, which will be applied toward your security deposit. We will also schedule a time to meet you to sign the lease. You will be required to pay the balance of your security deposit and the first month's rent at the time the lease is signed
5. Pets are not allowed.
