Thank you for your interest in our apartments! Please complete our Rental Application as accurately as possible and return it to this office at the address noted above. Should you have any questions about the application or any step in the application process, please do not hesitate to contact us.

Gan Aden at Chestnut comprises 6 two-bedroom, one-story "garden style" apartments, each with laundry hook-up. All units are barrier-free. Rent includes the heat and all the maintenance.

### As you complete the application process, please note the following:

- 1. These apartments are age-restricted. One member of the household must be 55 years of age or older.
- 2. Your household income must total at least \$30,000 annually. We will ask for verification of all sources of income.
- 3. When an apartment becomes available, we will contact you and schedule a time to show it to you. After you see the apartment, if you decide to proceed with your application, we will collect a \$30.00 fee for a credit history and criminal background report for each applicant and each household member over the age of 18.
- 4. After reviewing your application (including the credit history and criminal background report), we will contact you to tell you whether your application has been approved, and if so, we will offer you the apartment.
- 5. If you accept the apartment, we will ask you to provide us a \$400.00 non-refundable deposit, which will be applied toward your security deposit. We will also schedule a time to meet you to sign the lease. You will be required to pay the balance of your security deposit and the first month's rent at the time the lease is signed.
- 6. Pets are not allowed.
